SUBJECT: POSSIBLE STAFF MISCONDUCT RE: CO ROBERT BUSTER

**SYNOPSIS:** On Monday 9/22/03 WCCW I&I received an Incident Report (IR) dated 9/21/03 (see attachment 1) alleging Staff Misconduct by Intermittent Correctional Officer (CO) Robert Buster. According to the IR CO Buster had taken Inmate (I/M) [REDACTED] DOC# [REDACTED] into J-Unit property room on 9/20/03 where he took off his radio, embraced I/M [REDACTED] and began to kiss her. CO Buster is then alleged to have caressed I/M [REDACTED] right breast, her butt and then began to caress her vagina. On 9/21/03 I/M [REDACTED] saw CO Buster talking with another Inmate I/M [REDACTED] DOC# [REDACTED] in the J-Unit Office and after talking with her found out that CO Buster had said the same things to I/M [REDACTED] as he had to her the day prior. I/M [REDACTED] then stated that she had talked to her roommate I/M [REDACTED] DOC# [REDACTED] to find out what to do. CO Buster was interviewed and placed on no-call status pending completion of this investigation.

**INVESTIGATIVE INTERVIEWS:**

Inmate [REDACTED] DOC# [REDACTED] wrote a statement dated 9/21/03 (see attachment 2) and was interviewed 9/23/03, in this statement and interview I/M [REDACTED] related that on 9/20/03 around 0850 hrs. she had been locked out of her room after her shower. I/M [REDACTED] approached CO Buster to open her room. While they walked to [REDACTED] room CO Buster made comments like "MMM you sure smell good, if there's anything you need come talk to me, anything" CO buster was smiling as he said this. About five minutes later he walked by I/M [REDACTED] door and saw her in the corner pulling on her pants. Co Buster walked on then returned and asked I/M [REDACTED] if there was anything that she needed or that he could help with. CO Buster said all this with a big goofy grin on his face; I/M [REDACTED] replied that she was fine. Later that morning if I/M [REDACTED] passed CO Buster in the hall he would say "Miss [REDACTED] - Miss [REDACTED] UMMM UMMM Miss [REDACTED]" Between 1000 and 1015 hrs. I/M [REDACTED] was in the J-Unit CO's Office asking for the Avon book. CO Buster asked her to take a seat for a minute and began to tell her that she was a very beautiful woman "off the record" then began to ask her questions like

when she was getting out, what she like to do when she got out, was she married? At first I/M [REDACTED] stated she was flattered but then began to feel real uncomfortable. CO Buster then told I/M [REDACTED] that he had some property for her and took her to the unit property room. I/M [REDACTED] thought it might be the PJs she had ordered was not. CO Buster instructed I/M [REDACTED] to enter the room he then stepped in and closed the door. CO Buster then removed his radio and placed it on the shelve and approached I/M [REDACTED]. CO Buster then began to kiss I/M [REDACTED] and touched her on her right breast and lower area. I/M [REDACTED] stated that she was shocked and didn't know what to do. I/M [REDACTED] stated that she resisted then he told her that nothing happened but first asked if she was all right. I/M [REDACTED] wrote that she told CO Buster that she was very uncomfortable and he stated that he would deny everything.

I/M [REDACTED] saw I/M [REDACTED] in the CO's office with CO Buster on 9/21/03 and later approached her in the MSC yard. While talking they discovered that both had been told the same type of remarks by CO Buster. During her interview on 9/23/03 I/M [REDACTED] stated that CO Buster had told her that he had to be careful because another officer had lost his job when he got an inmate pregnant here. I/M [REDACTED] stated that she would take a polygraph to prove her statements.

Inmate [REDACTED] DOC [REDACTED] was interviewed and gave a written statement (see attachment 3) on 9/22/03. I/M [REDACTED] states that on 9/21/03 CO Buster called her to the CO's office. CO Buster asked I/M [REDACTED] to change her job from laundry to help with Linen exchange. After returning from the laundry exchange CO Buster again called her to the office and this time began to ask her questions like "where do you live, how much time do you have left?" Then CO Buster asked I/M [REDACTED] to take out his trash as I/M [REDACTED] bent over to get the trash she heard CO Buster say "oooh that's a fine body, you have everything all in the right places, I could work with that." I/M [REDACTED] states that she turned around and looked at him with uncomfortable confusion. CO Buster then asked I/M [REDACTED] to have a seat and handed her two clothing request slips and tells her "I think you need some blue jeans for that fine ass." At the Time I/M [REDACTED] states that she was flattered and kind of giggled. I/M [REDACTED] then filled out the slips and handed hem to him, he made a comment about the size of the jeans and then handed the slips back to I/M [REDACTED].

I/M [REDACTED] stated that she really needed the jeans and CO Buster stated, "I just gave you those slips to you because there are ears and eyes around here and I want you to look like you came in here for a reason." CO Buster then proceeded to tell I/M [REDACTED] in a quiet voice how fine she was and was sure all the inmates and guards had noticed her. CO Buster then said in a quiet voice "It can be done, it has been done before, but it's very dangerous." I/M [REDACTED] asked CO Buster if he didn't have a wife and re replied "Fuck her, I'm not worried about her, I am worried because another officer got a girl pregnant

here before and I don't want to go to jail or lose my job, you know what I'm saying, but believe me it can be done" and he smiled and winked.

CO Buster then asked I/M [REDACTED] to retrieve some passes that had fallen down the side of the desk, as he couldn't reach them. As I/M [REDACTED] bent over to reach for them CO Buster is alleged to have said, "you aren't wearing any underwear are you?" I/M [REDACTED] states that she did not respond but hurried up and finished as she walked past him he brushed up against I/M [REDACTED] chest and said, "damn that is nice." CO Buster then is alleged to have told I/M [REDACTED] to keep quiet and he would see her before he left work. I/M [REDACTED] states that she left in shock and went out to the yard until he was off duty. Later I/M [REDACTED] approached I/M [REDACTED] and said, "Did he say off the record things to you?" I/M [REDACTED] stated that she hesitated and then replied yes at that time I/M [REDACTED] stated that CO Buster had said the same things to her as he had to me on Saturday. I/M [REDACTED] also stated that CO Buster had taken her to the staff bathroom and kissed her.

Inmate [REDACTED] DOC# [REDACTED] was interviewed on 9/22/03 and related that she had been told by her roommate that CO Buster had taken her into the property room and had kissed and groped her. I/M [REDACTED] stated that at first I/M [REDACTED] had been flattered by the remarks made by CO Buster but that the incident in the property room had scared her. I/M [REDACTED] related that she had called her mother to ask for advise on what to do and had her mother call I/M [REDACTED] sister to relate what had occurred.

**CO Robert Buster:** was interviewed on 9/22/03 and denied all accusations. I/M Buster states that only one inmate was taken to the property room on the day in question and that she had blonde hair and wanted shelves for her locker. CO Buster stated that he would never mess with an inmate because he had heard about the CO that had gotten an inmate pregnant and had lost his job.

#### Investigation Facts:

- The stories of both inmates are close but not exact in phrases allegedly used by CO Buster
- I/M [REDACTED] was administered a Polygraph on 9/23/03 – the results of this test showed that I/M [REDACTED] was NOT being deceptive when she answered YES to the following questions: 1.) Did CO Buster kiss you and 2.) Did CO Buster caress your breast?

- A review of I/M [REDACTED] clothing requests did show a request for PJs on her last clothing request and issue form dated 8/24/03 (see attachment 4)
- A review of I/M [REDACTED] phone usage did in fact show a call to her mother on 9/21/03, when monitored the call did include the information of the CO Buster and I/M [REDACTED] incident. I/M [REDACTED] did request that her mother call I/M [REDACTED] sister and relate the information of the incident.
- When interviewed CO Buster stated, I wouldn't mess with an inmate because I've heard about the CO who had gotten an inmate pregnant and lost his job. Both inmates had stated that he told them variations of this same statement.

4. Between 10:00 am & 10:15 am I was told he had some property in the room for me and to come get it he tells me to step in. He steps in closes the door takes off his radio places it on the shelf and approached me kissing me feeling on my right breast and my lower area I was shocked and didnt know what to do I resist he then tells me nothing happend but first he asked me if I was alright I told him I was very uncomfortable and he says he will deny everything. I feel dirty and violated

On the day of 9-20-03 which was yesterday I was in the office between 10:00am and 10:15am asking the officer on duty McBuster for the Aush book he tells me to have a seat for a minute so I do this officer then starts telling me that I'm a very beautiful woman he says "off the record" he started to ask questions like when do I get out? where do I live? am I married? at first I was flattered but after what happens I feel real uncomfortable and I would not like to be in this officers presence ever again he then tells me by the way I have something for you in the property room so I'm like Okay cool to be honest I thought maybe it was the PT's I ~~was~~ requested so I followed him he tells come on step on in I'm like dumb I guess so I do it he comes in closes the door starts to take off ~~the~~ his radio and shoulder clip placed it on the shelf and comes right up on me and starts to kiss me and rub my breast and even my ~~love~~ love area I was shocked I didn't know what to do he asked me after he was through feeling around if I was alright and I tells him I can't believe I'm in this situation

Sept 21, 2003

On Sunday September 21, 2003 I was called to the office, by the officer, (Officer Buster) I had already signed up for my Unassigned job for that morning it was trash run. Officer Buster called me in to change my job to Laundry to help with Linen exchange. After returning from laundry exchange I was called in to the office again by officer Buster. I had a talk with him for a minute, he was asking me questions such as, "where do you live?", "How much time do you have left here?" etc... Then officer Buster asked me to ~~take~~ take out his trash, I of course said yes and he proceeded to move his backpack from behind the desk so I could do the trash. As I was bending over getting the trash out, he says, "look thats a fine body you have there everything all in the right places, I could work with that." I turned and looked at him with a look of uncomfortable confusion. By this time it was about 12:45pm I had arrived in his office @ 12:30pm. He told me to sit down in the chair and, walked over to the door where the Kites are, he hands me two clothing request slips and tells me, "I think you need some ~~of~~ a line ass." At the time I will

Admit that I was flattered, so I kind of jiggled. Then I filled out the request sheets and handed them to him, he made a comment about the size of my jeans, then he handed the slips back to me. I said, "Officer Buster I really do need those jeans." He said "I just gave those slips to you because here are ears and eyes around here and I want you to look like you came in here for a reason. He then proceeded to tell me in a quiet voice how fine I was and that he is sure that all the guards and inmates have noticed me. He then says, under his breath, "It can be done, it has been done before, but its very dangerous. I was a little confused @ that time and uncomfortable. I then asked him, "dont you have a wife?" He said, "Fuck her, I'm not worried about her, I am worried because another officer got a girl pregnant here before and I dont want to go to jail or lose my job you know what I'm saying, but believe me, it can be done." and he smiled and winked @ me. He then had dropped 50 passes down the side of the desk and told me he could not reach them if I could reach them because of my small arms. I said sure. "By this time I was feeling uncomfortable and vulnerable. I proceeded to get the passes for him bending over of course and he said, "You arent wearing any underwear are you?" I did not respond, I wasn't sure what to say. I hurried and finished and stood up to walk around his desk and he was walking right next to me and pressed against my chest and said, "Damn that

Is nice." He then told me to keep quiet and he (3) would see me later before he left work. I left the office in shock and went out to the yard until after I was off duty. I talked to no one until [redacted] came up to me and said, "Did he say off the record things to you?" I hesitated and said "yes, and 'ou and she proceeded to tell me things that he had also said to me, he said to her the day prior which was Saturday the 20<sup>th</sup> of September. She had told me that Officer Buster had taken her into staff bathroom and cornered her and kissed her. That was all she said being there were people all over, she said we'd talk tonight Monday 22<sup>nd</sup> 2003. after she returned from work.

This is my statement <sup>of facts</sup> to the best of my knowledge.
